



BYLAW OF THE TOWN OF BIRCH HILLS TO PROVIDE FOR ENTERING INTO AN AGREEMENT FOR OUTLINING THE RESPONSIBILITIES OF THE COUNCILS OF THE RURAL MUNICIPALITY OF BIRCH HILLS #460 AND THE TOWN OF BIRCH HILLS WITH REGARDS TO THE BIRCH HILLS & DISTRICT RECREATION BOARD

The Council of the Town of Birch Hills, in the Province of Saskatchewan, enacts as follows:

1. The Town of Birch Hills is hereby authorized to enter an agreement with the Council of the Rural Municipality of Birch Hills #460, the terms of which are attached hereto and marked Exhibit "A" for the purpose of outlining the responsibilities of the Town of Birch Hills and the Rural Municipality of Birch Hills #460 with regards to the Birch Hills & District Recreation Board.
2. The Mayor and the Administrator of the Town of Birch Hills are hereby authorized to sign and execute an agreement, the terms of which are set out in Exhibit "A" herebefore referred to.

BETWEEN:

THE RURAL MUNICIPALITY OF BIRCH HILLS,
#460, Birch Hills, Saskatchewan,
hereinafter referred to as the
Rural Municipality,

- and -

THE TOWN OF BIRCH HILLS
Birch Hills, Saskatchewan, hereinafter
referred to as the "Town",

WHEREAS the Town of Birch Hills shall be respon-
sible to ensure and pay for liability insurance coverage for the
Birch Hills & District Recreation Board and all its' facilities,
committees and sub-committees and their volunteers.

AND WHEREAS the Town shall receive and turn over
to BH&DRB any donations which it receives which have been desig-
nated to any facility or sub-committee under BH&DRB and the Town
shall issue receipts to the donators.

AND WHEREAS the Councils of the Town of Birch Hills
and the Rural Municipality of Birch Hills #460 shall appoint all
members of BH&DRB by resolution of Councils each year.

AND WHEREAS the Councils of the Town and the
Rural Municipality shall contribute funding on a year to year
basis for the operation of BH&DRB on an equal cost share.

AND FURTHER that once it is determined that the
BH&DRB is financially stable they will commence contributions
toward the salary of the Recreation Director.

AND FURTHER that after one year Councils will
assess the benefits of a Recreation Director and after two years
a decision made as to the feasibility of retaining this position.

AND WHEREAS the Councils of the Town and the
Rural Municipality shall keep the BH&DRB informed on all rec-
reation grants or information that they receive pertaining to
BH&DRB.

IN WITNESS WHEREOF THE RURAL MUNICIPALITY OF BIRCH
HILLS, #460 and the TOWN OF BIRCH HILLS have hereunto affixed
their corporate seals duly signed by their proper authorized
officers on their behalf this 13th day of April , A.D. 1993.
