**A BYLAW OF THE TOWN OF BIRCH HILLS IN THE PROVINCE OF SASKATCHEWAN,
AUTHORIZING COUNCIL OF THE SAID MUNICIPALITY TO ENTER INTO AN AGREEMENT
WITH THE STRUTHERS LAKE REGIONAL PARK FOR THE PURPOSE OF FURTHER
DEVELOPING AND MAINTAINING A REGIONAL PARK.**

THE Council of the Town of Birch Hills, in the Province of Saskatchewan, enacts as follows:


1. The Town of Birch Hills is hereby authorized to enter into an agreement with the Struthers Lake Regional Park for the purpose of further development and maintaining the regional park known as Struthers Lake Regional Park.
2. The terms of which are attached to this bylaw as Schedule A.
3. This bylaw shall come into force take effect from the day of signing and remain in force until December 31, 2022.
4. The Mayor and Administrator of the Town of Birch Hills are hereby authorized to sign and execute the said agreement on behalf of the Town of Birch Hills and to fix the corporate seal thereto.
5. Bylaw 10/13 is hereby repealed.

SCHEDULE "A"

THIS AGREEMENT made this 25th day of April, 2018
BETWEEN

STRUTHERS LAKE REGIONAL PARK AUTHORITY, a corporate body operating under the provisions of The Regional Parks Act, 1979.

The Party of the First Part

- AND -

THE TOWN OF BIRCH HILLS, a municipal corporation of and in the Province of Saskatchewan.

The Party of the Second Part

WHEREAS the parties named above desire to continue to associate with each other for the purpose of further developing and maintaining the regional park known as STRUTHERS LAKE REGIONAL PARK established under The Regional Parks Act, 1979,

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT the Council of the Town of Birch Hills, in the Province of Saskatchewan, agrees as follows:

1. TO CONTINUE to associate and work together with the STRUTHERS LAKE REGIONAL PARK AUTHORITY to further develop, operate and maintain STRUTHERS LAKE REGIONAL PARK.

2. TO AUTHORIZE an annual contribution to the STRUTHERS LAKE REGIONAL PARK in the amount of \$1,000.00.

THIS AGREEMENT shall be renewable at the end of FIVE years should the parties under this agreement so desire.

This agreement to become effective upon the passage of BYLAW 04/18, and forms part of BYLAW 04/18.
