BYLAW NO. 08-2021

A BYLAW TO PROVIDE FOR THE ENTERING INTO AN AGREEMENT RESPECTING FIRE PROTECTION FOR THE RURAL MUNICIPALITY OF **INVERGORDON NO. 430.**

The Council of the Rural Municipality of Birch Hills No. 460 in the Province of Saskatchewan enacts as follows:

- 1. The Rural Municipality of Birch Hills No. 460 is hereby authorized to enter into an agreement with the Rural Municipality of Invergordon No. 430 and the Town of Birch Hills respecting fire protection as stated within the Agreement in Appendix "A" and as per the attached map in Appendix "B" attached hereto and forming part of this bylaw.
- 2. The Reeve and Administrator of the Rural Municipality of Birch Hills No. 460 are hereby authorized to sign and execute the attached agreement in Appendix "A".
- 3. Bylaw No. 04/01 is hereby repealed.

APPENDIX "A"

FIRE PROTECTION AGREEMENT BETWEEN THE TOWN OF BIRCH HILLS AND THE RURAL MUNICIPALITY OF BIRCH HILLS NO. 460 AND THE RURAL MUNICIPALITY OF INVERGORDON NO. 430.

This agreement made in triplicate this 8 day of Quantum, 2021.

BETWEEN

THE TOWN OF BIRCH HILLS, a municipal body with the corporate office located in the Town of Birch Hills, in the Province of Saskatchewan, hereinafter called the Party of the First Part.

AND

THE RURAL MUNICIPALITY OF BIRCH HILLS NO. 460, a municipal body with the corporate office located in the Town of Birch Hills, in the Province of Saskatchewan, hereinafter called the Party of the Second Part.

AND

THE RURAL MUNICIPALITY OF INVERGORDON NO. 430, a municipal body with the corporate office located in the Hamlet of Crystal Springs, in the Province of Saskatchewan, hereinafter called the Party of the Third Part.

WITNESSETH AS FOLLOWS:

WHEREAS the Town of Birch Hills and the Rural Municipality of Birch Hills No. 460 have entered into an agreement to provide adequate fire protection within the boundaries of their municipal corporations; and whereas the Rural Municipality of Invergordon No. 430 has made a request for adequate fire protection for Division Six (6) within the said municipality as per the map in Appendix "B" from the Town of Birch Hills and the Rural Municipality of Birch Hills No. 460.



THEREFORE THE PARTIES HERETO AGREE AS FOLLOWS:

- The fire trucks and equipment owned by the Town of Birch Hills and the Rural Municipality of Birch Hills No. 460 may be called upon to answer fire calls within the boundaries as per the attached map identified as Appendix "B" of the Rural Municipality of Invergordon No. 430.
- 2. There shall be a charge for fire trucks and fire fighters for the costs associated to responding to calls in accordance with the Fire Department Rate Bylaw in effect and charged to the land owner in the Rural Municipality of Invergordon No. 430.
- 3. The Rural Municipality of Invergordon No. 430 shall pay an annual fee in the sum of Two Thousand and Two Hundred Dollars (\$2,200.00) with respect to this agreement to the Town of Birch Hills and the Rural Municipality of Birch Hills No. 460 on or before the first day of January of each year this agreement is in force.
- This agreement shall be deemed to be continuous unless either party submits thirty (30) days written notice prior to January 1st of any year of the intention to repeal or amend this agreement.
- This agreement shall come into force and take effect from the day of final signing of this agreement.
